



Chicago Style

No matter where your information comes from, you always need to cite your sources. The 15th edition of the *The Chicago Manual of Style* or the 6th edition of Kate Turabian's *Manual for Writers of Term Papers, Theses, and Dissertations* both ask that information be cited in 2 different ways--in footnotes or endnotes referenced in the text and in a bibliography at the end of the paper.

Books with more than three authors should use the first author's name and the phrase "and others."

Journal Article:

Because a newspaper may include several editions, and items may be moved or eliminated in these editions, page numbers are best omitted.

For online sources other than periodicals, include these elements as can be determined: author, title of page, title or owner of site, and URL. Date of access may also be included.

Online Magazine or Newspaper:

If a URL is likely to be rendered invalid because the page is time-sensitive or because the article is accessible by subscription only, give the date you accessed the information, and give the main URL of the website (i.e. <http://www.nyt.com>) rather than the page-specific URL.

Electronic Copy of a Journal Article from a Library Database:

14. Ilan Rachun, "The Meaning of 'Revolution' in the English Revolution (1648-1660)," *Journal of the History of Ideas* 56, no. 2, 195-215, <http://www.jstor.org> (accessed July 10, 2004).

Use this form for citing materials from Academic Search Premier, LexisNexis, JSTOR, and Project Muse as well as other databases where you can access full-text articles. Since these databases are accessed for a fee, you may choose to give only the main entrance of the service (i.e. <http://search.epnet.com> for Ebscohost databases), particularly if the article-level URL is unstable.
