

**Waiver for MCDC
Consent for Medical Treatment**

Permission of a parent or legal guardian must be obtained before medical treatment of any kind can be rendered to persons under 18 years of age. This consent form must be signed by a parent or legal guardian as evidence of your consent for treatment of the participant. If you are over 18 years of age, this consent form must be signed as evidence of your consent for treatment.

In the event that you/your child (as parent or legal guardian), do not want treatment rendered under any circumstances, your signature, evidencing refusal of treatment, is required below.

- I grant permission to the Muhlenberg Community Dance Center staff and/or its third party designees including Muhlenberg College employees to administer first aid care as may be necessary for myself/my child. **OR**
- I refuse permission to the Muhlenberg Community Dance Center staff and/or its third party designees to administer first aid care as may be necessary for myself/my child.

Controlled Substance Policy

I certify that I/my child will not be in possession of any controlled substances including those prescribed by a physician, as defined by the Controlled Substances Act while a participant in any Muhlenberg Community Dance Center classes.

Photography/Video Release

- I grant permission to Muhlenberg College to photograph and videotape classes and performances in which I am/my child is participating. I understand that these images will be used for documentation and to market future MCDC activities. MCDC participant's names are never printed in conjunction with marketing material.
- I refuse permission to Muhlenberg College to photograph and videotape myself/my child.

Muhlenberg College Indemnification

It is further understood and agreed that Muhlenberg College does not manage or facilitate the Muhlenberg Community Dance Center classes and or any of its activities. Muhlenberg College's facilities are being made available for the Muhlenberg College Dance Center classes.

I, in full recognition and appreciation of the hazards and exposures involved, do hereby voluntarily agree to assume all of the risks and responsibilities involving my/my child's participation in the Muhlenberg Community Dance Center classes, and further, I do for myself, my heirs, and personal representative(s) hereby defend, hold harmless, indemnify and release and forever discharge the Board of Trustees of Muhlenberg College and all of its officers, agents, employees and volunteers from and against any and all claims, demands, and actions, or causes of action of any sort on account of personal injury or death which may result from my/my child's participation in the Muhlenberg Community Dance Center.

Questions

What should I wear?

Creative Movement students should wear comfortable clothing that does not inhibit them from moving freely and safely; shoes are not required. Ballet and pointe classes require black leotard, pink tights, and ballet slippers. All other classes require any color leotard, black jazz pants/shorts, and appropriate footwear (jazz or tap shoes, bare feet).

Are there any discounts available?

Muhlenberg College students receive 30% off total fees. Faculty and staff receive 15% off total fees.

Families registering more than one child receive a 10% discount off their total tuition (not including Performance Company fee).

No more than one discount program per family.

Can I drop in and take a class?

Yes! The drop-in rate is \$18, payable at the door. This is a good option for trying out a class to see if it's the right class for you.

What is the MCDC Performance Company?

The Performance Company is a two-hour class for MCDC students who are already registered for technique classes, and who are interested in learning more about the performance side of dance. The Company is a full-year commitment and also includes outside classes and performances.

Company work includes warm-up, dance repertory and newly choreographed material, rehearsals, and being a part of the more "grand scale" performance pieces in our shows. The Company is for ages 10 and older with director approval.

Do I need to pay the \$15 registration fee?

Each family needs to pay the registration fee just once per year, so if you pay in the fall you do not have to pay again in the spring.
