#### **MINUTES:**

Discussion took place regarding a crosswalk at 24<sup>th</sup> and Liberty Streets. We put an officer there to observe and the biggest issue is that people are not crossing at a crosswalk.

Mr. Nemes requested some salt for the steps by the training room.

Mr. Jacob mentioned that some labs have been opened up and should not be open due to the contents in the labs. Much discussion surrounded the fact that the Registrar's Office maintains the R25 list (room scheduling software), and that this issue has been resolved.

## **AEDs:**

Mr. Huber got pricing from Phillips Heart Start brand this past June for \$1,434.55, which includes the AED, case, and child key. They have an 8 year warranty and a 5 year battery shelf life for the FRX Model. Mr. Nemes informed the committee that the AEDs on campus are being inspected today by Phisio Control. There are 14 units on campus; 4 or 5 are newer models. The older models (500's) will need to be replaced at some point.
